I take the utmost care with respect to the exposure, development, and delivery of photographs, however, in the event that I fail to comply with the terms of this contract, my liability is limited to a refund of monies paid.

Notice of Copyright: It is illegal to copy or reproduce these photographs elsewhere without the photographers permission, and violators of this Federal Law will be subject to its civil and criminal penalties. Amendments: No amendments or additions to this Agreement shall be binding unless in writing and signed by both parties.
